**RESOLUTION OF THE COMMITTEE OF THE TOWNSHIP OF  
GREENWICH, WARREN COUNTY, NEW JERSEY, OF INTENT TO  
FUND SPENDING PLAN SHORTFALL FOR AFFORDABLE HOUSING  
PROGRAMS IN THE TOWNSHIP'S HOUSING ELEMENT & FAIR  
SHARE PLAN**

**WHEREAS**, pursuant to the substantive regulations of the New Jersey Committee On Affordable Housing (COAH), certain portions of the Township's Third Round Housing Plan Element and Fair Share Plan as adopted by the Greenwich Township Planning Board on March 14, 2019 and endorsed by the Governing Body of the Township of Greenwich on March 21, 2019 may require a financial commitment by the Township; and

**WHEREAS**, COAH requires a municipality to resolve to address any shortfall in the funding of its affordable housing programs as set forth in the Spending Plan and the Fair Share Plan, including its willingness to incur bonded indebtedness, if necessary, to provide the funds required for the timely implementation of the Fair Share Plan;

**NOW THEREFORE BE IT RESOLVED**, by the Governing Body of the Township of Greenwich, in the County of Warren, New Jersey, that to the degree that the funds required for the implementation of the Township's Fair Share Plan, as will be more particularly set forth in the Township's approved Spending Plan, are not available at the time they are needed from all available affordable housing funding sources, the Township will provide the funding needed to cover any shortfall through appropriations in the Township's annual budget, bonding, or any other legal means, with the understanding that any future affordable housing funding which becomes available may be used to reimburse the Township for the costs incurred.

2019 HOUSING ELEMENT AND FAIR SHARE PLAN


**WHEREAS**, the Greenwich Township Land Use Board adopted a 2019 Housing Element and Fair Share Plan on March 14, 2019;
