**TAX SALE CERTIFICATE CANCELLATION**

**WHEREAS**, due to a 2011 property tax balance, Block 16 Lot 22 was sold at tax sale on December 4,

2012 for \$537.60, Certificate #11-80044, and listed as sold to Stuart Lasher; and

**WHEREAS**, Stuart Lasher has responded verbally and in writing that he did not purchase this lien and

there is no record of the lien being recorded in the Warren County Clerk's office; and

**WHEREAS**, there is no documentation in the files on lien #11-80044 as to its validity; and

**WHEREAS**, a subsequent lien known as 14-00005 was sold November 14, 2014 to an outside lienholder and later redeemed on October 15, 2020; and
