**ORDINANCE #114-2021**

**AN ORDINANCE AMENDING AND ESTABLISHING ADDITIONAL SECTIONS  
CHAPTER THREE, POLICE REGULATIONS, SECTION 7.14, RESTRICTIONS ON  
THE USE OF PARKS, ETC., OF THE GREENWICH TOWNSHIP, COUNTY OF  
WARREN, MUNICIPAL CODE**

**WHEREAS**, it is the desire of the governing body of the Township to provide for the general welfare and public safety of all citizens of the Township within its public parks; and

**WHEREAS**, it is the determination of the governing body that additional restrictions on park activities are necessary to provide for the public safety and general welfare and recreational needs of all citizens of the Township.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Greenwich, County of Warren, State of New Jersey, as follows:

Chapter 3, Section 7.14(j) of the Township Code is to be amended and read as follows:

No person or organization shall erect or install any structure, fixture or memorial of any kind in any Township Park or on any Township open space including but not limited to, a bench, monument, walkway, paver, tree, shrub, or planting of any kind whatsoever unless they first obtain permission from the Township Committee.

It shall be the Policy of the Township that all proposed improvements and donations to any park of any bench, monument, walkway, paver, tree, shrub, or planting of any kind, whether permanent or temporary, be submitted to the Open Space and Parks Committee who, with input from the Superintendent of Public Works, may choose to endorse the project and refer the same to the Township Committee. In no case will the addition of a memorial placard or sign be permitted.

Chapter 3, Section 7.14(i) of the Township Code is to be amended and read as follows:

No person or organization shall erect or post any sign of any kind displaying the name of any individual, company or organization who may have donated to any park or recreation activity or event, whether permanent or temporary.
