THE APPLICANT FOR THE UTILIZATION OF THE TOWNSHIP PAVILION HEREBY ACKNOWLEDGES THAT (HE/SHE) HAS BEEN ADVISED THAT THE TOWNSHIP OF GREENWICH IS NOT IN ANY MANNER INVOLVED WITH THE SERVING, REGULATING OR SUPERVISING OF, OR IN ANY RESPECT WHATSOEVER WITH THE USE OF INTOXICATING BEVERAGES IN ASSOCIATION WITH THE PAVILION PERMIT.

THE APPLICANT FURTHER ACKNOWLEDGES THAT THE TOWNSHIP MAY NOT HAVE INSURANCE COVERAGE FOR ANY INJURIES TO THE PERSON OR PROPERTY OF THE APPLICANT, THE APPLICANT'S GUESTS OR THIRD PARTIES WHICH MAY BE SUSTAINED AS A RESULT OF IMBIBING ALCOHOLIC BEVERAGES AT THE TOWNSHIP PAVILION. THE APPLICANT IS THEREFORE DIRECTLY RESPONSIBLE FOR ANY INJURIES SUSTAINED OR CAUSED BY SAID APPLICANTS OF GUESTS AT THE TOWNSHIP PARK.

THE APPLICANT FURTHER ACKNOWLEDGES THAT THE TOWNSHIP MAY NOT HAVE INSURANCE COVERAGE FOR ANY INJURIES TO THE PERSON OR PROPERTY OF THE APPLICANT, THE APPLICANT'S GUESTS OR THIRD PARTIES WHATSOEVER.

THE APPLICANT HEREBY ACKNOWLEDGES THAT THEY HAVE OBTAINED (HIS/HER) OWN POLICY OF INSURANCE TO PROVIDE COVERAGE FOR ANY INJURIES TO THE PERSON OR PROPERTY SUSTAINED BY THE APPLICANT, GUESTS OR INFLICTED UPON OTHER THIRD PARTIES AS A RESULT OF THE UTILIZATION OF INTOXICATING LIQUORS AT THE MUNICIPAL PARK BY THIS PERMIT AND PROOF OF INSURANCE HAS BEEN PROVIDED TO THE TOWNSHIP.
